3. Consent Agenda:

Katie Hammer, Executive Director, said that there are significant leaks in the office due to the snow melt. We will have a roofing company come in to look at the roof. Katie also said the Redmond Senior Center is beginning to develop a business plan and she will be attending those meetings to grow our partnership.

Matt Gilman asked if there was any way to distribute a free one time use pass to come
in and use our facility to say thank you. This is something that the district staff and
board will explore.
