Mike Elam said soccer registration is ending on the 20<sup>th</sup>. He said that adult basketball is doing well and fitness class attendance is up. Mike also said that they are adding in a womens softball recreation league.

Katie Hammer said that Redmond Brew Fest will be happening in August and the district is one of the benefactors of funds raised during this event. They are currently going through their permitting process.

Katie spoke about her monthly meeting with regional park and recreation directors and offering a regional staff meeting in April to create a staff networking opportunity.
