4.0 Consent Agenda:

Approval of the General Board Meeting Minutes from April 12, 2016 Approval of the Workshop Meeting Minutes from April 22, 2016 Acknowledgement of Receipt of April Financial Summary Heather Richards made a motion to approve the consent agenda as presented. Action as a Result of Executive Session

Tina Hinchliff made a motion to approve Executive Directors, Katie Hammer's employment agreement as a result of the executive session. Ed Danielson seconded the motion. Tina Hinchliff amended the motion to the approval of Executive Director, Katie Hammer's employment agreement minus financial compensation until further information is disbursed. Ed Danielson seconded to the amendment of the original motion. The amended motion passed unanimously.

Approval of Resolution #11 201-516 Resolution to Abolish the Facility Construction and Equipment Depreciation Funds and Create Operating Reserve and Capital Reserve Funds.

Katie Hammer explained the purpose of Resolution #11 2015-16 which is a recommendation that the RAPRD board abolish the two capital reserve funds; Facility Construction and Equipment Depreciation Fund and use the existing fund totals for create capital reserve fund that can be used for capital projects and create a new operating reserve fund to build up the reserves. The current capital reserve funds are no longer serving the greater needs of the district.

Heather Richards motioned to approve resolution #11 2015-16 to abolish the facility construction and equipment depreciation funds and create operating reserve and capital reserve funds. Ed Danielson seconded the motion. Motion passed unanimously.

Katie Hammer said that the implementation committee will be making a recommendation on the recreation facilities and program plan in June.
